1. Introduction

This Privacy Policy explains how **Scythra** ("we", "us", or "our") collects, uses, and protects your personal data when you visit our website and purchase **SYTR tokens** during our Initial Coin Offering (ICO) via <https://scythra.com>.

We are fully committed to protecting your privacy and complying with relevant data protection laws, including the **General Data Protection Regulation (GDPR)** and the **California Consumer Privacy Act (CCPA)**.

2. Information We Collect

When you participate in the Scythra ICO or visit our website, we may collect the following information:

a. Automatically Collected Data:

- IP address
- Device type, OS, and browser type
- Pages visited, referral URLs, and timestamps
- Location data (approximate, based on IP)

b. User-Submitted Data:

- **Wallet address** (required to process SYTR token purchases and later distribution)
- **Email address** (optional, if you subscribe to updates or communicate with us)

Note: We **do not** collect or store personally identifiable information such as your full name, government ID, or billing address.

3. How We Use Your Data

We use your data strictly for the following purposes:

- To process SYTR token purchases securely

- To track and record blockchain-based purchases for accurate future token distribution
 - To contact you regarding important updates if you've opted in
 - To analyze site traffic and optimize platform performance

4. Legal Basis for Processing (GDPR)

Under the GDPR, we process your data based on:

- **Contractual necessity:** To fulfill your request to purchase SYTR tokens
 - **Legitimate interests:** For website performance and fraud prevention
 - **Consent:** For marketing communications (optional and opt-in only)

5. Your Rights (GDPR & CCPA)

You have the right to:

- Access the data we hold about you
- Request correction or deletion of your data
- Object to or restrict certain types of processing
- Withdraw consent at any time (for optional data use)
- Request that we do not "sell" your data (under CCPA, although we do not sell data)

We do **not** sell, trade, or share your data with third parties for marketing or commercial purposes.

We may share data only with trusted service providers (e.g., hosting, analytics tools) under strict data protection agreements, and only to the extent necessary.

- We use SSL encryption, firewalls, and access control protocols to secure your data.

- Wallet address and transaction logs are stored securely and only for the duration needed to fulfill our obligations (e.g., token distribution after pre-sale ends).
 - We do not retain data longer than necessary.

We use cookies and analytics tools (e.g., Google Analytics) to understand how users interact with our website and improve performance.

You can disable cookies in your browser settings at any time.

9. Buying SYTR Tokens

When purchasing **SYTR tokens** on our website:

- Your **wallet address** is logged and stored securely.
 - No personal ID or financial credentials are required.
 - Payments are made in USDC via connected wallets (e.g., Phantom).
 - Tokens will be distributed manually after the 6-month lock period, based on on-chain transaction logs.
